

**General Conditions of participation for:**

## *2nd International Conference on Large-Scale Grid Integration of Renewable Energy in India*

(the "Conference")

and accompanying events like dinner and study trips to the Conference which will be held from

**4–6 September 2019 in New Delhi, India**

### **Application**

In order to participate in the Conference, an online-registration internet application is necessary. Applicants will receive emails confirming their request for registration. However, final admission is subject to explicit approval by the Organizer. Registration is only valid with second email confirming registration. Only participants with this confirmation by the Organizer may attend the Conference. Therefore, it is necessary to provide the e-mail address when applying for registration to the Conference.

The registration is legally binding and obliges the participant to attend. If the participant chooses not to attend the Conference, he/she needs to inform the organizer.

### **Conference Attendance**

All tickets and Workshop materials will be given to the participant upon check-in at the Conference venue. Participants are requested to wear their congress badges all the time for identification and admittance to the conference rooms.

Each participant is responsible for his own actions during the Conference and is liable for all damages caused by himself/herself regarding the property of the organizer and/or other third parties, including other participants.

Participants are expected to follow the instructions of the organizer as well as its representative agents. In case a participant infringes such instructions or violates the Workshop policies, he/she will be given notice, and, in case of recurrence, he/she may be excluded from the Conference. In particularly serious cases, the participant may be excluded without prior notice.

### **Recording**

The Conference' participant acknowledges that the Conference will be video and audio taped and that participants may be filmed as part of the audience and that by completing the registration, the participant is granting permission to be videotaped for commercial purposes and agrees to the following: being filmed, videotaped, audio taped or photographed by any means; full use of participant's likeness, voice and words as recorded at the Conference without compensation; specifically waiving all rights of privacy during the videotaping or filming.
